Affiliate members shall be **individuals** who are not primarily involved in the sale or leasing of property, but who have interests in the real estate profession. A firm or company may have multiple Affiliate members.

Please read your application carefully. As an applicant for Affiliate Membership in the Fayette County Board of REALTORS<sup>®</sup>, Inc., you agree as a condition of membership that you are engaged in a specialty of the real estate profession other than selling real property, are not associated with a firm engaged in selling real property; and agree, if elected to membership, to abide by the Constitution, Bylaws, and Rules and Regulations of the Local Board, State Association, and the National Association, and Ethics of the National Association of REALTORS<sup>®</sup>.

Upon joining FCBR, you also become a member of the Georgia Association of REALTORS<sup>®</sup> (GAR) and a portion of your dues will be forwarded to them (see chart on page 3). The enclosed materials outline the services, benefits and responsibilities of your Board membership.

Once your application is received and processed, you will be emailed your welcome letter, payment receipt and a NRDS number to access both the FCBR and GAR websites.
