For companies desiring primary membership in the Board, there is a one-time application fee of \$100.00. Along with application, please send a letter to the Fayette County Board of Realtors on your company letterhead indicating your firm's interest in becoming a member company, the name of the person who will serve as the Designated REALTOR (usually the Broker) and the effective date you desire to join. When the letter and application fee are received, they will be processed and presented to the Board of Directors for approval.

For licensees desiring primary membership in the Fayette County Board, Board bylaws dictate that they must join the Board within thirty (30) days of affiliating with a member office. Firms holding licensees longer than 30 days prior to joining will be responsible for dues to original 30 day mark.

If a licensee is a primary member of another Board of REALTORS in Georgia and is seeking secondary membership in the Fayette County Board, then only prorated local dues would be due.

There are many benefits of membership in the Fayette County Board of REALTORS. General Membership Meetings and Events are held seven times during the year. The Board also has a comprehensive continuing education program offering classes each month. Our annual Awards Dinner honoring Circle of Achievement members is a highly anticipated highlight.
